School Psychology Program Requirements:

Program Admission Requirements:

- 1) Undergraduate grade point average (GPA), typically 3.0 or above
- 2) Graduate GPA (if applicable), typically 3.5 or above
- 3) Verbal and quantitative scores on the Graduate Record Examination, typically a composite score of 1,000 (Old GRE) 300 (New GRE) or above
- 4) Three letters of recommendation
- 5) Previous related volunteer or appropriate work experience desirable
- 6) Statement of professional goals
- 7) A sample of scholarly work
- 8) Evidence of professional promise
- 9) An on-campus interview strongly encouraged; alternative phone interview

Program Retention Requirements:

- 1.) Coursework expectations require that students meet or exceed a "B" grade level or higher in each course. If students receive a grade level of "C" or below in any courses taken in core areas (Areas A, C, D & E; exception is Scientific Foundations), they must retake the course.
- **2.)** Students must demonstrate acceptable professional behaviors. If students do not adhere to professional behaviors, the faculty and supervisor will outline a plan for improvement. If improvement is not made within an agreed-upon time frame, all faculty will convene to discuss the most appropriate, individualized plan of action for the student.
- **3.)** For each student to pass the Masters Exam, they must obtain an overall Satisfactory score for the exam (a mean of 3) across all faculty members as rated on the Masters exam rubric. Students who do not pass the exam are provided with a remediation plan.

Program Exit Requirements:

- 1) Satisfactory performance in practicum experience
- 2) Passage of PRAXIS-II examination in school psychology for recommendation for provisional certification and internship
- 3) Successful completion of the 98 hour curriculum including six credit hours of internship
- 4) Successful completion of Master's Oral Examination.
- 5) Successful completion of the Research Portfolio
- 6) Successful completion of the Qualifying Examination
- 7) Successful completion of the Doctoral Dissertation Proposal
- 8) Successful completion of the Doctoral Dissertation Defense
- 9) Successful completion of the Predoctoral Internship

Requirements for Recommendation for Certificate:

- 1) Eligible for master's degree after 36 credit hours completed.
- 2) Eligible for Provisional Certificate after 48 credit hours completed and passage of PRAXIS-II examination in School Psychology. The Provisional Certificate is valid for one year of full-time or two years of half-time service as an intern in Kentucky. The program requires that 27 hours of Professional Practice curriculum and 8 hours of Supervised Experience (i.e., 6 hours of EDP 674) must constitute 35 hours of the 48 credit hours. The remaining 13 credit hours may be completed within the Psychological Foundations, Scientific Foundations, and Educational Foundations curricular areas.
- 3) Eligible for Standard Certificate and Ed.S. degree after completion of the 69 hour curriculum including six credit hours of internship, completion of Ed.S. internship and Oral Exam and passage of PRAXIS-II examination in School Psychology. The Standard Certificate is valid for serving in the position of school psychologist in a school system but not in private practice outside of school situations. All program requirements MUST BE COMPLETED prior to the program deeming the candidate eligible for the Standard Certificate. (Note: Some states and school systems are now requiring criminal background checks prior to certification and hiring.)

Kentucky educator certification requirements are subject to change. Before registering for the test(s), please check the Education Professional Standards Board website at www.epsb.ky.gov for current test requirements and current cut scores. You may also contact the Division of Professional Learning and Assessment at 502-562-5778 or toll free at 888-598-7667. To receive a UK recommendation that you are eligible for a state educator certificate, you must have taken the Kentucky EPSB required examinations and met the Kentucky EPSB cut score requirements.
