Students will collect data, provide staff development training, develop and implement behavioral interventions, evaluate intervention effectiveness and provide standardized assessments to children, youth and young adults with disabilities. These experiences will improve UK students ability to work with a variety of students as well as provide a valuable service to the orphanage. The orphanage is government-funded and located in Ladyzhyn, Ukraine where they serve individuals with disabilities ages 4-35.

According to the CDC website and based on proposed activities, all students would need to be up-to-date on their standard vaccinations, including Hepatitis A and B and tetanus.

There are currently no safety risks with Ukraine in terms of political or ethnic conflicts. Common precautions need to be taken in cities (e.g., pickpockets).

The primary health concerns is that we will be working in direct contact with individuals with a variety of disabilities. For this reason, Hepatitis A and B and tetanus vaccinations are recommended in case of accidental contact. There may be slight strenuous activities (e.g., lifting a person). Finally, the orphanage is located in a rural area surrounded by forests, which means that stray animals could be present (although I have never seen any).

Course Description

In-depth study of a current and topical problem or issue in the education of exceptional children and youth. May be repeated to a maximum of nine credits. A title is assigned each time the course is offered. (*Bulletin Description*)

Course Purpose

This course is designed to provide UK students with an opportunity to complete a study/service abroad in Ukraine. The course will include traveling to Ladyzhyn, Ukraine to work in a government-funded orphanage for individuals with severe disabilities ages 4-35. Due to a lack of resources and personnel, there are numerous challenges associated with the patients that live in the orphanage. UK faculty and students will provide valuable assessments, training, and interventions to increase quality of life for orphanage patients. These assessments, trainings and interventions will be based on accurate identification of disability, decreasing self-injurious behaviors, increasing opportunities to engage in functional communication and education, providing interventions and training to staff that can better meet their patients needs. This course will include extensive work while at the orphanage, with directors (Allday and Campbell) providing on-site training and evaluation for UK students.

Course Delivery

This course is a study abroad that will be delivered as a face-to-face course. Students will observe and interact with Ukrainian people on a daily basis, including staff and patients within the orphanage, engage in extensive discussions related to course content, and participate in applied course activities that <u>WILL</u> be used to improve the quality of life of the staff and patients.

Unbridled Learning Initiatives

This course will provide students an opportunity to advance their knowledge and mastery of the "tools" associated with Kentucky education reform, including the Kentucky Core Academic Standards (as they become available), assessment literacy – assessment *for* learning, Characteristics of Highly Effective Teaching and Learning, College and Career Readiness, and the new accountability system as it becomes available. As students carry out projects and complete assignments, they will address one or more components of the Senate Bill 1 initiatives.

Academic Integrity:

Per university policy, students shall not plagiarize, cheat, or falsify or misuse academic records. Students are expected to adhere to University policy on cheating and plagiarism in all courses. The minimum penalty for a first offense is a zero on the assignment on which the offense occurred. If the offense is considered severe or the student has other academic offenses on their record, more serious penalties, up to suspension from the university may be imposed.

Plagiarism and cheating are serious breaches of academic conduct. Each student is advised to become familiar with the various forms of academic dishonesty as explained in the Code of Student Rights and Responsibilities. Complete information can be found at the following website: http://www.uky.edu/Ombud. A plea of ignorance is not acceptable as a defense against the charge of academic dishonesty. It is important that you review this information as all ideas borrowed from others need to be properly credited.

Part II of *Student Rights and Responsibilities* (available online http://www.uky.edu/StudentAffairs/Code/part2.html) states that all academic work, written or otherwise, submitted by students to their instructors or other academic supervisors, is expected to be the result of their own thought, research, or self-expression. In cases where students feel unsure about the question of plagiarism involving their own work, they are obliged to consult their instructors on the matter before submission.

When students submit work purporting to be their own, but which in any way borrows ideas, organization, wording or anything else from another source without appropriate acknowledgement of the fact, the students are guilty of plagiarism. Plagiarism includes reproducing someone else's work, whether it be a published article, chapter of a book, a paper from a friend or some file, or something similar to this. Plagiarism also includes the practice of employing or allowing another person to alter or revise the work which a student submits as his/her own, whoever that other person may be.

Students may discuss assignments among themselves or with an instructor or tutor, but when the actual work is done, it must be done by the student, and the student alone. When a student's assignment involves research in outside sources of information, the student must carefully acknowledge exactly what, where and how he/she employed them. If the words of someone else are used, the student must put quotation marks around the passage in question and add an appropriate indication of its origin. Making simple changes while leaving the organization, content and phraseology intact is plagiaristic. However, nothing in these Rules shall apply to those ideas which are so generally and freely circulated as to be a part of the public domain (Section 6.3.1).

Please note: Any assignment you turn in may be submitted to an electronic database to check for plagiarism.

Legal Action

Students charged with violations of criminal law will be suspended immediately from the Teacher Education Program and/or field experiences until the case is settled. Students are responsible for reporting such charges to the Program Faculty Chair.

Commitment to Diversity & Equity

The Special Education Program is committed to: making diversity central to policies, decisions, and practices; evaluating progress toward diversity in the program; disseminating results widely; and using these results to strengthen diversity for the Commonwealth.

Students who fail to attend class on a regular basis, participate as expected, and/or conduct themselves professionally or ethically will be required to meet with the instructor to set improvement goals, and may face failure or expulsion based on due process policies set by the College of Education and Teacher Education Preparation program.
